As of August 2, 2024, GBL holds directly and through its subsidiaries 10,601,735 GBL shares representing 7.7% of the issued capital and holds no shares under the liquidity agreement. On that date, 27.6% of the seventh share buyback program is executed 1.

Following GBL's decision to use the safe harbour² regime for the on-the-market share buybacks in the context of a EUR 500 million envelope, the liquidity contract with an independent financial institution has been suspended for an indefinite period.
