As of November 8, 2024, GBL holds directly and through its subsidiaries 12,075,009 GBL shares representing 8.7% of the issued capital and holds no shares under the liquidity agreement. On that date, 47.7% of the seventh share buyback program is executed¹.

Following GBL's decision to use the safe harbour² regime for the on-the-market share buybacks in the context of a EUR 500 million envelope, the liquidity contract with an independent financial institution has been suspended for an indefinite period.
